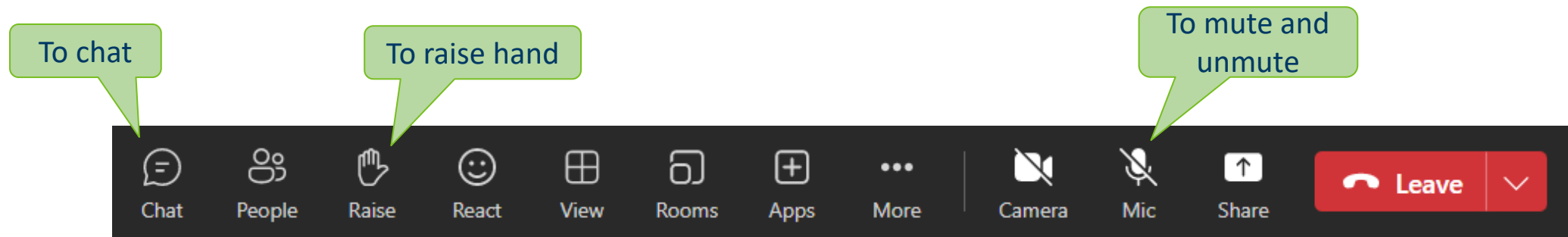
# Hybrid Meeting Approach
