## Potential community well impacts

\*These numbers are subject to change based on MDH's implementation of new PFOA/PFOS HBVs

\*\*Not all wells in the total number of wells may be in use (some are/will be abandoned or taken out of service, etc.), and the sum of the first three columns may not add up to the total number of wells (fourth column)

# Potential private well impacts

- Around half of the total number of private wells in the East Metro (7,000 8,000) have been sampled
- Approximately 650 residential wells that have been sampled will need treatment that didn't previously
- At least 1,300 residential wells will need to be resampled using newer lab methods that have lower reporting limits

### Next steps

- Continue evaluating Priority 1 funds as community projects are implemented, and as new projects are needed
  - Co-Trustees have been discussing additional treatment needs due to updated HBVs with individual communities and work group members
- Updated costs were shared with work group members in October 2023; Co-Trustees are evaluating the additional costs for treating additional wells and will provide an update during the spring work group meeting
  - This evaluation will be included in the Annual Review and any reallocation needs will be discussed with work group members

#### Next steps

- Approximately 1,300 private wells need to be resampled; residents are being informed though letters and phone calls that their wells should be resampled
  - Will take 1-2 years to resample ~ 1,300 wells
- Co-Trustees would like to work with communities to share this information with their residents to get the word out for private well testing

### Next steps

- Whole-home treatment systems will be installed in homes that have wells with health risk advisories
  - Timing to complete all GAC installations is unclear at this point, as the MPCA is in the process of adding additional contractors to increase installations

#### • EPA MCLs and MDH HBVs Next Steps

- Expect EPA MCLs to be finalized for PFOA and PFOS in early 2024
- Identify and discuss additional treatment needs of final EPA MCLs and MDH HBVs with individual communities
- Spring 2024
  - Next biannual work group meeting
