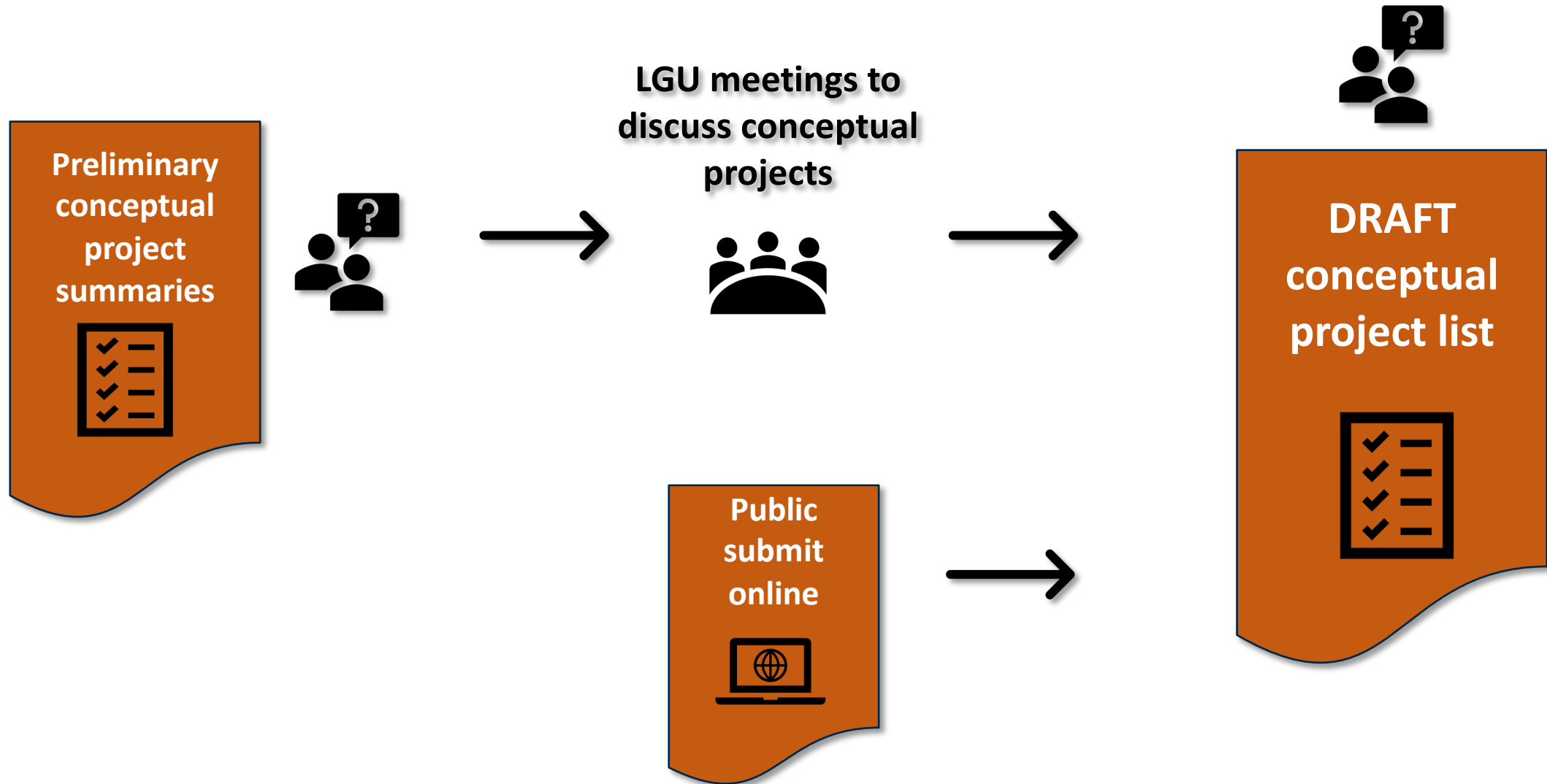

Progress-to-Date

- Wood is currently developing preliminary conceptual project summaries for the identified communities in the East Metro area
 - Consistent with the list of water supply improvement options
 - Informed by discussions with the LGUs
 - looking for inter-community solutions
 - Projects will be bundled into scenarios and evaluated

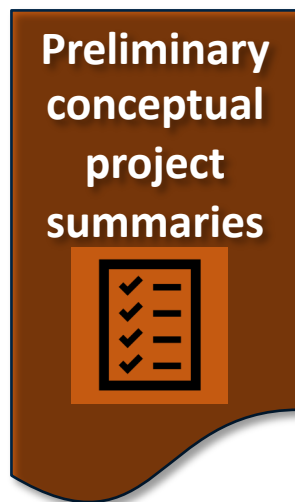
Next Steps

Next Steps: Subgroup 1

- Wood is meeting with each LGU and other members of Subgroup 1 this month to share the preliminary conceptual project summaries and request feedback
- The refined list of conceptual projects will be shared with Subgroup 1 for a second round of review in September



Next Steps: Work Groups

- Work group members are encouraged to coordinate with their Subgroup 1 member to provide input in the initial list of conceptual projects
 - Work group members may also submit project ideas via the public portal
- The refined list of conceptual projects will be shared with the Work Group members to review and provide feedback in September

We are looking for ideas aimed at improving drinking water quality and/or quantity that are consistent with Priority 1. At this time, we are not taking project ideas related to: recreational use projects, habitat improvements projects, and administrative or communication projects.
